#### 5) Joint Emergency Management Coordinator Update

- ICS Classes Mr. Fleming explained that as of May we have finished two sets of ICS 300 and 400. The final set of trainings was held in Hoffman Estates by the IFSI training group out of Champaign. We will hold off on bringing any additional ICS courses to the area until next calendar year as we focus on other areas,
- Planning There are a number of plans that are currently being developed for the various municipalities. At this point in time we will refer you to the update for community specific details.
- Exercise There are a number of exercises that are planned for the coming months including the festivals for many of the communities. Mt. Fleming explained that a noteworthy exercise would be the region 9 hospital coordination center exercise being run out of Northwest Community Hospital. During this exercise all three of our major medical facilities will be playing roles and holding their own exercises to coincide with the region. The JEMS team has also coordinated with these hospitals, our JEMS members, and Cook County to hold a smaller table top exercise regarding logistics following the half day long full-scale exercise.

#### 6) New Business

#### A. ESDA Rules

- Mr. Fleming explained a set of proposed rule changes to the Illinois Administrative Code that would affect the ESDA rules. In his explanation Mr. Fleming pointed to a set of comments he had shared with the JEMS members prior to the meeting. Mr. Fleming highlighted that the proposed changes would have a significant negative impact on the accredited EMAs and would potentially overwhelm the current EMA and JEMS staff. A major sticking point of the proposed changes was the timeline for their adoption, which is outlined as being within one year of the rule change approval. Mr. Fleming pointed out that in many places these types of adoptions take five years or more and are often given additional funding to come into compliance. In this case we are not being offered additional funds to meet these new criteria, rather funding is being threatened by these changes.
- Mr. Norris suggested that as a group we look into how this can be impacted by the JEMS member communities and suggested that a letter be drafted for the accredited agencies as well as for the non-accredited agencies.

#### **B.** National MRC

• Mr. Fleming explained that the national MRC coordinator had reached out inquiring into the possible creation of a regional MRC in order to consolidate what currently exists and possibly bring back members whose

MRC has dissolved. Mr. Fleming explained that he did not want to take someone's volunteer corps out from under their control but would rather like to open up opportunities for regional training which would be more in line with the 2017 work plan.
