APPROVAL OF MINUTES

EXECUTIVE DIRECTOR'S UPDATE

Telecommunicator Hiring Process:

Two Telecommunicators from the joint testing process with DU-COMM were hired for the current vacancies and will begin January 29th.

UPS - Next Steps:

A replacement UPS was approved in the Calendar Year 2018 budget. As reported at the last Joint Board meeting, a third party consultant was utilized to assess the UPS situation to ensure a third unit was still needed. needed and an RFP/bid specification will be released in the first quarter of 2018 for this important piece of equipment for the center. Having three units provides the needed diversification and redundancy.

Management Sexual Harassment Training:

Ericka Thomas, an attorney with John Kelly's firm, provided sexual harassment training for management staff on December 19, 2017. The training focused on management's role and a review of our policy.

NEW BUSINESS

Achievements 2017

John mentioned a few achievements from the meeting packet, including:

- 1. Barrington Countryside Fire Protection District was added to NWCDS.
- 2. NWCDS completed 7200 hours of training in 2017, with the help of Training Manager Lauri Orwig.
- 3. Our Quality Assurance Specialist, Curt Peddicord, along with reviewers, averaged 125 reviews monthly, exceeding the National Standards created by NENA and APCO.
- 4. NWCDS hired a new HR/Finance Manager, Terri Svec.
- 5. Schaumburg Radio Tower was replaced.
- 6. Jim and Jason Hunt continue making minor radios repairs prior to shipping them out to Motorola.
- 7. Schaumburg Alarms were added.
- 8. Facilities: Repaired and resurfaced the parking lot, upgraded the WIFI, and replaced the humidifiers.

Executive Committee Minutes January 18, 2018

OLD BUSINESS

Response Determinants – Update

Although we ran into some snafus last year while going live with response determinants due to ID Networks, we worked around their issues and the TC's went live as of January 3rd this year. Priority Dispatch, the company who provides the protocols, heard we were dispatching using Response Determinants and wants to help us mine our data, so we are allowing them access.

New CAD - Update

John informed the Executive Committee that the CAD Committee has agreed on which companies we need to move forward on with regard to CAD contract negotiations. He is looking for a consensus from the Executive Committee to bring this information to today's Joint Board Meeting for approval.

Chief Walsh asked about data conversions and John stated that that data conversions from ID Networks were included in the price. The Committee discussed some of the billing aspects of the new CAD since each traffic stop will count as an incident. John explained that we plan to keep the bills as stable as possible and a can review at a later time.

Implementation with MCP

The Consensus was to allow John, along with Mission Critical Partners and our attorney to begin contract negotiations with the top two CAD vendors reviewed. Additionally, a vote will be cast with the Joint Board of Directors on whether or not to use MCP for the implementation of the new CAD.

Fire RMS

The Fire Chiefs will have to decide on whether to stay with Firehouse or switch to Image Trend for their Records Management System. Image Trend will be giving a presentation on Wednesday, January 24rd, at 1:30pm in the Training Room of NWCDS. Calendar invites were sent and attendance is encouraged.

Firstnet - Update

The governor opted in with the Firstnet and AT&T Contract. It doesn't mean we have to go with Firstnet, as pricing will be reviewed. Verizon might come out with more competitive pricing due to Firstnet as well. Additionally, John stated that the Center may be able to reduce costs by renting out some tower space.

OTHER BUSINESS

Long Grove Fire Department

Long Grove Fire is interested in a contractual relationship with NWCDS like PRFPD and BCFPD are currently. This is in the very early stages, as they just met with John and Brian yesterday. Chief Anderson stated that it made sense operationally, and Chief Koeppen agreed. John reiterated that this is in the very early stages and no decisions have been made.

Executive Committee Minutes January 18, 2018

Pulse Point APP

Chief Lambel asked if any departments are looking into or using the CPR/AED Pulse Point App. It was brought up in some of the CAD meetings and Chief Lambel thought it might be a useful App, although it is not supported by Image Trend. The Committee discussed some pros and cons and Mick Fleming commented that it's a good community education engagement piece that typically works out well for citizens.

John stated that he would be willing to set up a product demo with Pulse Point and will work with Chief Lambel to coordinate and set up a demonstration.

AHFD

Chief Koeppen explained that over the past few weeks, others may have heard, "Ambulance 5 is responding," because AHFD is trying out manning a 5th ambulance, especially between 8am and 5pm.

MPPD

Chief Haas welcomed Chief John Koziol from the Mount Prospect Police Department.
