# NEW BUSINESS CESSA Hyperlocal Meeting

Special Executive Committee Minutes August 28, 2024

John Ferraro called the Hyperlocal meeting due to CESSA ACT 50 ILCS 754, which is expected to go live July of 2025. He also discussed the Response Matrix and the 9-1-1 PSAP Responsibilities to various type of calls Telecommunicators receive.

After a couple of Short Demonstrations, the group discussed the need for Training and had various questions for different scenarios on how to respond.

Dr. Matthew Jordan from Northwest Community Hospital explained how the hospital handles some mentally ill patients while the group talked about various levels of mental health. He also explained how the area has a robust group of 590 Mental Health Providers and described how they would be involved with mental health calls but is awaiting additional direction from the state with regards to the CESSA Act.

The group deliberated the various Police and Fire Responsibilities and talked about the need for additional training and public education. There were several questions from the attendees that John said he would ask at the Statewide or Regional Area Committees.
