5) Joint Emergency Management Director Update

Mr. Fleming reported that the full update was included in the meeting package, and highlighted that there was a mixed set of updates including the following:

• A short review of the even year biannual NIMS compliance certification. In the past every ICS certificate that people had were collected and

bundled. Now a summary is provided with details on training, exercises, mutual aid and EOC skill sets.

- The Director reminded everyone of the revision of the Emergency Management mutual aid agreements brought up earlier in the year. Based on the shift from the state in terms of what language is appropriate for mutual aid agreements. There was a recent update to the MABAS agreements and similar updates are likely coming to the PW man agreements. All using similar indemnification Language, updating it into the modern era.
- Director Flemming discussed the local impact from federal budget issues on grants that have come up in a some communities. These are hazard mitigation programs and working through hazard mitigation and or COVID-19 grant closeout. With Hurricanes Helene and Milton, the FEMA budget, the Disaster Recovery Fund and the Disaster Relief Fund are very, very low right now. FEMA has gone to immediate needs funding. All of the preparedness grants are basically on pause until there is either another continuing resolution or full budget. The life safety issues in North Carolina that take precedent over regular budget considerations.
- The status of the incident management assistance team was also reviewed. With co-commanders identified, each community is asked to identify individuals who they think would be appropriate. The numbers have varied across communities and a kickoff meeting is being planned.

6) Old Business

A. Barrier Grant

• The barriers were delivered last month. They were delivered to and are currently being stored at Arlington Heights Public Works. JEMS is working with the staff of the Dispatch Center to process the reimbursement of the grant funding.

B. JEMS Intergovernmental Entity

• Director Fleming noted that the IGA agreement is moving forward, in near final draft form and has been reviewed through a few drafts in the village managers working group. A final draft will be provided to board members shortly.
